

Criminal Proceedings in Absentia: Azerbaijan's Tool Against Exiled Critics

Overview of a Systematic Practice Used to Silence Dissenting Voices in Exile

Transnational Repression and Azerbaijan

Alongside domestic repression targeting dissent, the Azerbaijani authorities use transnational repression to pursue critics abroad. These tactics enable the extraterritorial persecution of dissidents and members of the diaspora. Exiled activists and human rights defenders are subject to constant surveillance by Azerbaijani state structures.

Research by Freedom House shows a rise in transnational repression bγ authoritarian governments. In 2023, the Parliamentary Assembly of the Council of Europe (PACE) adopted a resolution expressing serious concern about the growth of these incidents and urging member states to prevent and investigate them. The resolution identified China, Russia, Turkey, Egypt and Tajikistan as the main countries involved in transnational repression, and included Azerbaijan in the list. It underlined that Azerbaijan has engaged in extraordinary renditions of opponents, particularly journalists, and coordinated physical and verbal attacks against exiled activists.

According to the UN High Commissioner for Human Rights, common forms of transnational repression include:

- Violence and intimidation abroad;
- Harassment through extradition requests, unlawful arrests or deportations;
- Abuse of security laws with extraterritorial effect;
- Restrictions on mobility;
- Digital threats or attacks;
- Proxy punishment of relatives or associates inside the country.

A <u>study</u> commissioned by the European Parliament identifies several obligations of host states towards exiled human rights defenders facing transnational repression. These include:

- Protection from harm, intimidation, privacy breaches and digital insecurity, with preventive policing and risk assessments treating transnational repression comparable to state-sponsored violence or organised crime;
- Prompt and impartial investigations into incidents occurring on their territory, with criminal accountability for perpetrators;
- Strict protection against refoulement and against abusive extradition requests or politically motivated indictments;
- Support for secure residence status, documentation and rapid reporting mechanisms;
- Safeguards against the misuse of domestic systems, including ensuring that immigration border authorities do not automatically on alerts from abusive states, non-cooperation with politically motivated criminal proceedings;
- Active protection of freedom of expression and civic space in exile, enabling exiled defenders to continue advocacy work without intimidation.

In this study, Azerbaijan appears as a state extending repression abroad surveillance, attacks on exiles, intimidation of relatives, criminal cases in absentia, misuse of INTERPOL channels and restrictions on mobility. It is described as an entrenched authoritarian state that systematically represses dissent at home and abroad, and increasingly benefits from the European Union's shift towards pragmatic, interest-based engagement that sidelines human rights concerns.

Azerbaijan conducted extraordinary renditions of at least two prominent journalists: Rauf Mirgadirov (from Turkey) and Afgan Mukhtarli (from Georgia).

Exiled critics and human rights defenders are also placed under persistent surveillance.

The authorities have targeted exiled critical bloggers in Europe, often labelled in domestic propaganda as "vulgar opposition". These individuals criticised the President and his family using language the authorities deemed offensive. Repressive acts against them have included violence and intimidation, digital attacks and punishment of relatives inside Azerbaijan, as detailed in the European Parliament's study.

The recent expansion of criminal proceedings in absentia, together with public summonses and threatened or forthcoming international search warrants, shows that the authorities intend to broaden their transnational repression tactics. INTERPOL diffusion and extradition procedures risk being used to harass exiled critics, disrupt their mobility and expose them to temporary detention or questioning when travelling. Nearly all critical civil society organisations and independent media outlets are currently subject to criminal prosecution in Azerbaijan. Anyone associated with these organisations in exile is therefore at risk of politically motivated extradition attempts and related complications with law enforcement authorities in host states.

This pattern provides reasonable grounds to conclude, at a prima facie evidentiary standard, that the Azerbaijani authorities use criminal proceedings in absentia, abusive extradition requests and mutual legal assistance procedures in bad faith as tools of transnational repression.

State-led Repression: Expansion of Prosecutions in Absentia

Since mid-March 2025, the Office of the Prosecutor General of Azerbaijan has initiated criminal proceedings against leaders and staff of human rights oriented and critical NGOs. These organisations operated mainly under "service contract" regulations and received funding from the United States Agency for International Development (USAID) and the German Marshall Fund (GMF).

The Office of the Prosecutor General has revived an NGO-related criminal case that was closed in mid-2023. It is now unofficially referred to as the "Renewed NGO/USAID case".

Between mid-March and early April 2025, several NGO leaders were charged with financial crimes. Some were remanded in custody pending trial. Others were placed under house arrest or restrictive police supervision.

Soon after, the authorities initiated criminal cases against exiled critical bloggers, chiefly accusing them of incitement to subversion or riots on the basis of their online content. This cluster of

prosecutions has become known as the "Critical Bloggers Case".

For exiled civic activists and bloggers, the Office of the Prosecutor General <u>launched</u> criminal proceedings in absentia. The authorities used public television to summon these individuals for questioning. At the same time, official and progovernment outlets reported that remand orders in absentia had been issued or that international search warrants would follow. In the months that followed, several trials in absentia began, resulting in convictions for incitement to subversion or riots.

To date, the authorities have issued public summonses to exiled critics in two main waves:

- 1. March-April 2025: proceedings absentia against 13 individuals
- 2. November 2025: proceedings in absentia against 10 individuals

A further isolated summons was issued in August 2025.
